7. Other matters require attention of the management have been reported in the Annexure to this report as required by the Society.

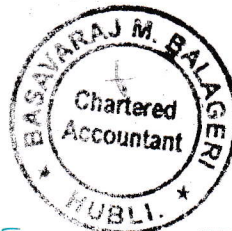
